A description of the several Highway Districts in the town, together with the amount assigned to each for repairs for the year 1873—74.

No. 1—Begins at the Gloucester line; thence easterly on the Snake Hill road to Greenville; also, the cross road to the Johnston line, and the road from the Long House, past the house of Stephen Steere to the Gloucester line. \$150.

No. 2—Begins at the Asahel Phetteplace house; thence over Meeting House bridge to the Johnston line; also, the new road past the house of William Windsor, to the Powder Mill Turnpike; also, from the forks of road easterly of Arnold Brown's to Reapers Brook; also, from Meeting House bridge to Wolf Hill; and from forks of Log Road, at Abraham Smith's house, easterly to the Flat Rock on the Wolf Hill road. \$300.

No. 3—Begins at the Johnston line, on the Powder Mill Turnpike road (so-called); thence westerly, on said Turnpike road, to the Hotel in Greenville. \$400.

No. 4—Begins on the Farnum Turnpike, at the Winsor Farnum homestead estate; thence southerly, to the Johnston line; also from Benjamin A. Winsor's to Flat Rock; also, from Benjamin A. Winsor's to the Turnpike, at the Hotel; and from Abiah Mowry's to the Farnum Turnpike, at E. Smith's; and from Flat Rock, on Wolf Hill, to the house of Edwin W. Mowry, with a piece of new road from Reaper's Brook, to the last mentioned road, and the new road from Wolf Hill road to the Powder Mill Turnpike. \$175.

No. 8—Begins at the North Providence line; thence northerly to the four corners, near Job Shaw's. \$250.

No. 9—Begins at the Lincoln line; thence southerly to the forks of the road, north of Asahel Angell's house; also, a piece of road, running past the house of Andrew J. Clark, deceased, to the brook West of Ransom J. Greene's. \$125.

No. 10—Begins at the forks of the road, north of Asahel Angell's; thence northerly to the road, running past Edward S. Enches. \$70.

No. 11—Begins at the North Smithfield line, near the Howard farm; thence southerly, past the house of Edward S. Enches to the town line; also, from said road past the house of William S.

Enches to the town line; also, from said road to the bridge near the house of Benjamin Harris. \$70.

No. 12—Begins at the Douglas road, near the Town House; thence easterly past the house of Jirah Ballou, to the road near the house of Mowry Smith. \$100.

No. 13—Begins at the forks of road near the Alfred Smith house; thence easterly past Duty Shippee's to the forks of road at the top of the Samuel Shippee hill. \$125.

No. 14—Begins at the four corners near the house of Job Shaw; thence northerly to the North Smithfield line \$175.

No. 15—Begins at the forks of the road, near the Yellow Tavern; thence northerly past the house of Ezra Whitford, to the North Smithfield line; also, from Ezra Whitford's over the Branch road to the Douglas Turnpike; also, from the Yellow Tavern, past the Daniel Aldrich place to the North Smithfield line; and also, the Farnum Turnpike from the Yellow Tavern to the house of Robert Harris. \$270.
